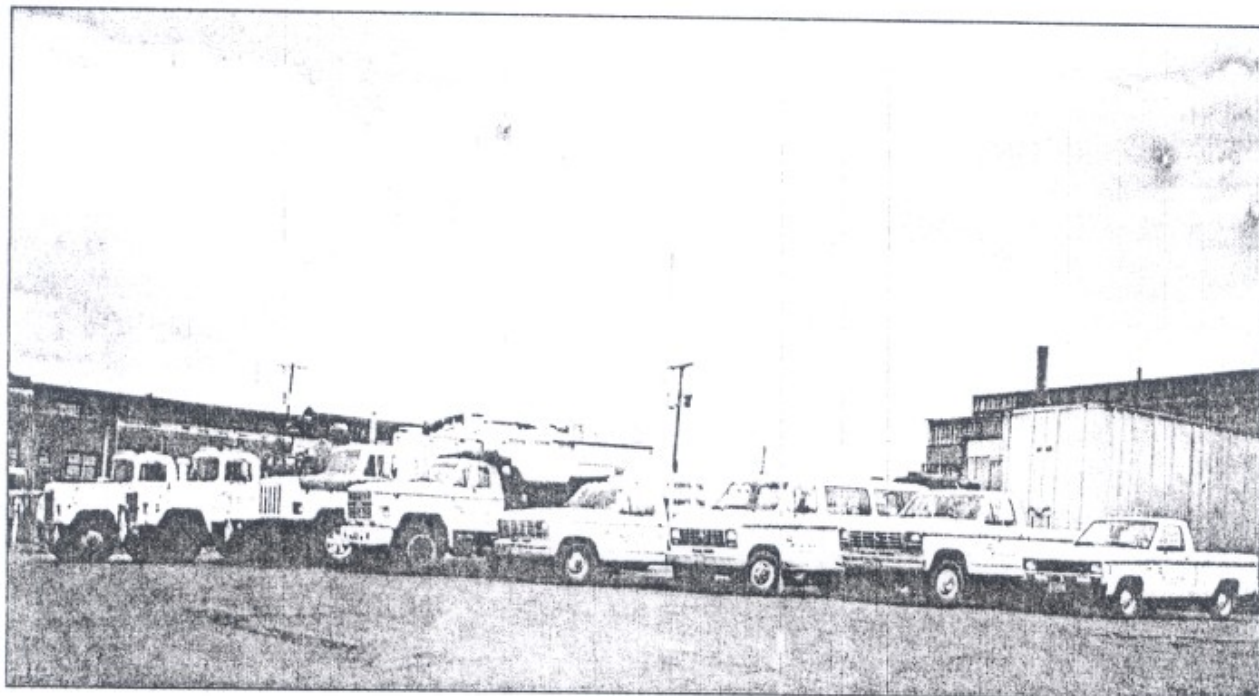

Our site supervisors are located throughout New Jersey. So no matter where you are, a Clean Venture supervisor can be on site fast — usually within the hour.

If needed, we immediately dispatch our *EMERGENCY* response vehicles from our Perth Amboy headquarters with a fully equipped response team, ready to tackle any waste problem.

From our headquarters, we keep in constant mobile phone or radio contact with the site supervisor, and dispatch additional manpower and equipment as the job requires.

We can handle any marine oil spill, from a minor leak to the crash of a major oil tanker.

We boast a fleet of vessels specially designed to handle marine oil spills. These vessels are equipped with the boom needed to contain the spills, absorbents and other materials and equipment required to remove the oil.

Our fastest and largest boat, with its twin 155 HP engines, is kept on call, in the water, 24 hours a day, seven days a week. At a moment's notice, it can be dispatched to any marine site for quick containment of the spill, thereby minimizing clean-up cost.

PACKAGING.

We check your drums and containers to make sure they conform to regulations for transport. If your waste needs to be packaged, we can put it in containers for shipment.

TRANSPORTATION.

Clean Venture is a licensed transporter of hazardous materials. Using our own fleet of vehicles, we haul your waste away and take it to the licensed disposal site. And we make sure proper manifests and paperwork accompany each shipment, so that you fully comply with state and federal regulations.
